



**CONSENT OF PARENTS AND OTHERS
COMMITMENTS FOR THE BENEFIT OF THE MINOR**
Risk acceptance



I declare that I am duly authorized to act for and on behalf of _____, minor, so that he participates in one or more of the activities sanctioned by **CHALLENGE SUR NEIGE ORMSTOWN**, and this, according to the terms and conditions of this document.

I know the type of events sanctioned by **CHALLENGE SUR NEIGE ORMSTOWN**, which involve the use of a motorized vehicle in rough conditions.

I know the nature of the activity or activities proposed as well as the experience of the Minor and am convinced that he has the skills and ability to participate in it.

I acknowledge that the paths and routes that the Minor will take cannot be subject to valid supervision and that they may, moreover, deteriorate during the course of the activity and become more dangerous.

I recognize that many obstacles, such as rocks, trees, crevices, etc., may be found on the trails and tracks.

I recognize that the configuration of these trails and layouts as well as the very nature of the activity and the maneuvers of the participants create significant dangers and risks.

I therefore acknowledge that by participating in these activities or events, the Minor is exposed to serious risks of injury, which can be significant, even fatal.

I declare that I have informed the Minor of all the aforementioned risks or any other risks of which I become aware and will make sure to withdraw him from the activity if I judge that these risks are too great for him.

I declare that it is with full knowledge of these significant risks and dangers that I agree to allow the Minor to participate in any of the events sanctioned by **CHALLENGE SUR NEIGE ORMSTOWN**.

Waiver of all recourse

For and on behalf of the Minor, I waive any recourse for any damage that the Minor may suffer during the latter's participation in one or more of the events sanctioned by **CHALLENGE SUR NEIGE ORMSTOWN**, whether this damage is caused by an accident, whether through the fault of a third party or otherwise. This waiver benefits **CHALLENGE SUR NEIGE ORMSTOWN**, its directors, employees, members, successors and assigns as well as promoters, participants, trail operators, trail owners, officials, rescue personnel, sponsors, advertisers, or any other natural or legal person who participated in the realization of the activity, its implementation, or its promotion.

If, despite this commitment, the Minor were to take legal action against the aforementioned beneficiaries, I will hold them harmless from any condemnation that may be pronounced against them, both in capital, interest and costs, and will reimburse the lawyers' fees required in order to ensure their defense against such an action.

Assignment of visual rights

I hereby assign to **CHALLENGE SUR NEIGE ORMSTOWN** all rights of the Minor to the use of images, photos, films or videotapes of his person taken during **CHALLENGE SUR NEIGE ORMSTOWN sanctioned activities**, and this for all purposes of documentation, promotion or marketing.

Other terms

I undertake to ensure that the Minor respects the sporting code of **CHALLENGE SUR NEIGE ORMSTOWN** as well as all the competition regulations of **CHALLENGE SUR NEIGE ORMSTOWN**.

I acknowledge that without my consent to the participation of the Minor and my acceptance of the terms hereof, the Minor would not have been authorized to participate in any of the events sanctioned by **CHALLENGE SUR NEIGE ORMSTOWN**.
